- 1. The Promotion commences on 1 September 2021 and is valid until 30 October 2021 ("Promotion Period").
- 2. To qualify for the Promotion, Partners must be an existing rhipe Partner and a new customer of Acronis ("Eligible Partners").
- 3. Eligible Partners must sign up and commit to a one of the following plans for a minimum 12-month period prior to the end date of the Promotion Period:
 - \$350AUD commit per month for 12 months (\$350 Plan)
 - \$1,500AUD commit per month for 12 months (\$1,500 Plan) (collectively "Eligible Purchases").
- 4. The Eligible Purchases will include a ramp-up period for the first three (3) months ("Ramp Up Period").
- 5. During the Ramp Up Period of an Eligible Purchase, the minimum commit per month will be waived and Partners will only be charged for actual usage, ie. If you commit to a \$350 per month plan and only accrue fees to the value of \$20, you will be charged the lesser amount.
- 6. Each Eligible Purchase may also receive access to discounted licencing fees as follows:
 - o \$350 Plan will have access to licence fees charged under the \$1,500 Plan
 - \$1,500 Plan will have access to licence fees charged under the \$3,000 Plan
- 7. All monetary amounts unless otherwise specified refer to Australian Dollars (AUD).

- 13. rhipe may collect your personal information including but not limited to full name, email, address, in order to conduct the Promotion and may, for this purpose, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required or applicable, to Australian regulatory authorities. - 14. rhipe may, at any time, request from Partner, any proof or evidence of performance or compliance with these terms and conditions.
